Terms and Conditions :

Art. 1: Period of stay:

The customer signing this contract concludes for a fixed term and he is not allowed to stay longer. He must occupy himself the Chalet and mustn't rent it to others.

Art.2 : Conclusion of the contract :

The booking becomes valid, once the Town hall (Mairie) of St. Germain du Bois received the deposit of 25 % of the total price, one signed and dated exemplary of the booking form as well as an IBAN and Swift, before the mentioned date. The 2nd copy should be kept by the customer.

Art. 3 : Cancelling by the customer :

A) Cancellations must be notified by 'registered letter' sent to the Town hall (mairie).

- Cancellation 30 days before the beginning of the stay/ arrival day:

the owner (mairie) will keep 25% (that means the deposit)

- Cancellation less than 30 days before the arrival day:

the 100% will be kept by the owner (mairie) , except in cases of force majeure

B) No- Show :

If the customer does not show up in between the 24 hours following his arrival date, the present contract is no more valid. The owner may freely dispose of his Chalet. He will keep 100% of the rental cost.

C) Shortened stay :

In case of shortened stay, you have to pay the price corresponding to the total length of the stay, the amount belongs to the owner.

Art. 4 : Cancelling by the owner :

When the owner has to cancel the stay before the arrival day, he must inform the customer by registered letter (with acknowledgment of receipt). The customer will be (without any legal procedure) reimbursed for his payments and will receive a compensation for the damages caused by the cancellation. (the allowance will be same amount as the penalty he would have had to pay if it was the customer who had cancelled).

Art. 5: Pets :

PETS ARE PROHIBITED IN THE CHALETS – NO PETS IN THE CHALETS !!!

Art. 6: Arrival and departure :

The customer has to arrive the day and during the hours notified on the booking form. If you are late, please phone to the owner/ responsible.

High season : arrival times on Saturday between 15h30 and 18 h, departure on Saturday between 9h30 and 10 h.

Between September and June :

Arrivals : from Monday to Saturday : 14h00 - 16h00 pm

Departure : Monday to Saturday : 9h00 - 11h00

On Sunday : arrival and departure : between 9h and 10 h

Art. 7: Settlement

The balance has to be paid 1 month before the arrival date (to be sent to the Mairie de St. Germain du Bois).

Art. 8: Deposit:

At your arrival you will be asked for a deposit of 280.-€ covering any possible damage (2 checks) - (200.-€ for damage in the Chalet, broken dishes etc and 80.-€ if you don't do the cleaning before leaving). This deposit will be refunded 8 days after your departure, the price of possible damages deducted. In case the deposit does not cover the damages, you will receive an invoice to be settled to the 'Trésor Public'.

Art. 9 : Using the campsite

All customers have to respect the present terms and conditions and ensure the peaceful character of the campsite.

Art. 10: Accommodation capacity:

The number of expected persons is notified on the booking form. If, however the number of persons arriving exceeds the accommodation capacity of the chalet, the owner may refuse the access to the accommodation. This refusal cannot be considered as a modification or breach of contract since the number of holidaymakers is no more according to the signed booking form. If the customers leave, they will not be reimbursed.

Art. 11:- Insurance

The customer is responsible for all damage caused by him. He is strongly advised to buy an insurance covering these risks.
